

Code of Conduct Policy 2022

Introduction

1. The ethical climate of an organisation is an essential element in establishing its credibility and furthering its mission. Indigo U3A is committed to providing its members with a trustworthy, fair, honest environment based upon equal opportunity to participate in U3A programs and activities.

Purpose

2. The purpose of this policy is to document Indigo U3A's Code of Conduct for members and the processes that will be followed where a breach of the Code of Conduct is reported.

Policy

3. Indigo U3A commits itself to operating in accordance with this Code of Conduct for the benefit and protection of the organisation and of members' personal rights.
4. Every member of Indigo U3A has the right to:
 - feel safe and respected
 - a supportive and positive learning environment
 - participate in learning, social and recreational opportunities
 - receive services fully compliant with U3A norms
 - make a complaint and receive prompt and fair resolution thereof
 - have access to guidelines, policies and procedures adopted by Indigo U3A.
5. Every member of Indigo U3A has the responsibility to:
 - respect the beliefs, needs and background of others
 - act and speak respectfully
 - understand and follow the organisation's guidelines, policies and procedures
 - carry out all activities in an appropriate manner
 - work cooperatively for the benefit of all members
 - maintain positive relationships
 - care for the property and possessions of the organisation and members
 - help create an inclusive environment
 - report actual or potentially unsafe situations or conduct
6. The principles set out in this Code of Conduct are intended to apply to any U3A-related context including classes, activities, social functions, and meetings.
7. The principles set out in this Code of Conduct apply equally to all members.
8. A breach of this Code of Conduct will result in disciplinary action.



Procedures

9. Where a person believes they have been subject to treatment or conduct that is in breach of this Code of Conduct he/she may lodge a complaint may be made to any member of Indigo U3A's Committee of Management. The Committee Member will inform the President immediately.
10. Any complaint of a breach of this Code of Conduct will be handled by Indigo U3A's Committee of Management.
11. Any queries about this Code of Conduct should be referred to Indigo U3A's Secretary.

Responsibilities

12. Indigo U3A's Committee of Management is responsible for:
 - developing, adopting, implementing, publishing and reviewing this Code of Conduct
 - investigating and resolving any complaint made about a breach of this Code of Conduct.
13. Indigo U3A's Secretary is responsible for
 - receiving and responding to enquiries about this Code of Conduct
 - receiving complaints about an alleged breach of this Code of Conduct and for bringing the matter before the Committee of Management promptly.

Authorisation

14. This Policy was approved by the Committee of Management of Indigo U3A Inc. on 8 September 2022.
